Upon your execution and delivery of this agreement, your license to use the Luna Imaging Inc. software product on the originally registered machine under the Luna Imaging Software License Agreement shall terminate. You will be issued a "NEW SOFTWARE KEY" and your original license will be registered to the new designated host computer to which you have requested transfer.
